At a time when even former Tory ministers like Ian Duncan Smith are admitting that the cuts they are imposing on welfare are unfair it is important we show our opposition to what the Government is doing. Call for a Debate on the Local Government Pension Scheme Investment Regulations

5 million people rely on the LGPS to pay their pensions. Government wants powers over LGPS investment funds, but they could gamble away members' money on infrastructure projects. This is not allowed in any other UK scheme, including the MPs'. The LGPS must be invested in members' best interests.

Parliament must debate this issue and make the government accountable for these powers of intervention as any such direction may breach the law. Specifically Article 18 paragraph 3 of the EU Directive 41/2003 Institutions for Occupational Retire Provision: "Member States shall not require institutions located in their territory to invest in particular categories of assets."

The Trade Union Bill

Last month we reported that the 3rd reading of the Bill was on the 16th March and line by line examination of the Bill took place .

Amendments discussed covered clauses 3, 4, 7, 8, and 10-13, of the Bill.

A second day of report stage is scheduled for 19 April — which should cover clause 14 — check-off or DOCAS.

Keep our Neighbourhoods Safe

The Government has revised police funding for 2016-17 which will mean many forces will have their budgets slashed in the coming months. The scale of the funding cuts means that police forces across the North West are considering huge reductions to the services they provide.

Amongst the valuable roles that are under threat is that of Police Community Support Officers (PCSOs). PCSOs are crucial to effective neighbourhood policing. They are active in our communities and build good relationships with local people. They attend schools and children's homes to talk to young people about issues such as crime and drug abuse. They help make our public transport safe to use and they address anti-social behaviour on our streets.

PCSOs are the main point of contact for the victims of crime. They help to prevent, deter and resolve crime.

A failure to properly resource neighbourhood policing will take us back to the 1970s - with police in panda cars chasing crimes that have happened already. There would be less support for victims of crime, the public would feel more vulnerable, and our communities would be less safe.

PCSOs are accessible frontline staff and they are there for people to turn to. They are trusted by their communities and we cannot afford to lose them.
