Reject below inflation offer - Vote Yes for Action over pay

UNISON are currently carrying out an indicative ballot of our members in local government and schools over the Government's latest pay offer.

The Government offer of £1290 does not come anywhere near the union's claim for 10 percent or £3000 (whichever is the greater). For all grades this is a below inflation offer meaning that once again our pay falls behind.

The Resolution Foundation estimates that annual repayments for those re-mortgaging in 2024 are set to rise by £2,900 on average.

Private rental prices have seen average monthly rent for new tenancies in the UK push up by 9.6% to £1,283.

The average cost of a part time (25 hours a week) childcare place for a child under two in a nursery in Britain has risen 5.6% to £7,134 per year, while for a two-year-old that cost has jumped 6.1% to £6,912 per year.

Our income tax bills are going up because the Government have frozen the threshold where you start paying tax.

Our pay has fallen by 25% since 2010. A large rise is needed to begin to restore it to its previous value.

The indicative ballot has begun and you should get an email or if you are not on email a paper ballot soon. Voting closes on **Friday 28 June at midday**.

Councils face 'existential crisis' without proper investment from next government

In a new white paper produced by the Local Government Association this month they have calculated that Council's face a £6.2 billion shortfall in the next 2 years.

Local Government funding has already been cut back by over 40% since 2010.

Commenting on the report UNISON's head of Local Government Mike Short said:

"Wave after wave of budget cuts to essential services has harmed communities immensely, with the worst off always the hardest hit.

"Authorities have been forced to sell off buildings, open spaces and other prized assets, and cut thousands of jobs. But still their books won't balance – and now scores of town halls face effective bankruptcy.

"Without a sustained programme of proper investment many more will go under. This cannot be allowed to happen. Local services, and the councils that provide them, are too important to lose."
